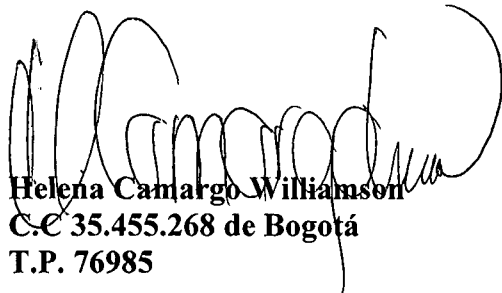

Dear applicant/representative,

Present application discloses amino acid/nucleotide sequences. According to the EPO Official Journal 6/2011 [& Rule 5.2. PCT], if nucleotide/amino acid sequences **are disclosed** in a European/International patent application, the description shall contain a *sequence listing* complying with the **WIPO standard ST. 25**.

The sequence listing is required for the explicit sequences given in the description, claims and/or figures of the present application. Please note that the sequences which are not identical to the sequences disclosed in the prior art (SNP's, fragments and/or modifications) should be given in the sequence listing.

The expressions nucleotide and amino acid sequences mean an unbranched sequence of **ten or more** contiguous nucleotides and an unbranched sequence of **four or more** contiguous amino acids. Nucleotide sequences shorter than 10 contiguous nucleotides and amino acids sequences shorter than 4 residues must not be included in a sequence listing.

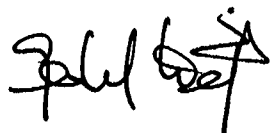
