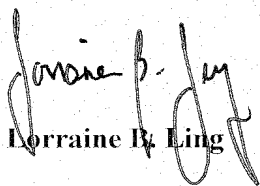

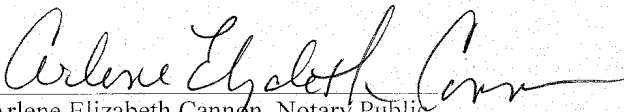

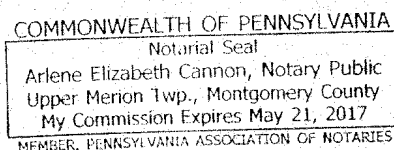

The name of the City and County where the document is being signed must be placed in front of “City,Country/Ciudad,País.”

LEGALIZATION OUTSIDE OF COLOMBIA

The execute Power of Attorney must be legalized using the Apostille, which normally requires that a Notary Public authenticates the signature of the person signing the document and subsequently the Notary Public’s signature legalized using the Apostille process.
