Regarding independent claim 1, the prior art of record does not disclose, teach, or fairly suggest, "wherein the filter material comprises a metal complex dye" in combination with the other limitations of the claim.

Regarding independent claim 10, the prior art of record does not disclose, teach, or fairly suggest "the dye comprising a photon emission quencher" in combination with the other limitations of the claim.

Regarding independent claim 18, the prior art of record does not disclose, teach, or fairly suggest, "the reaction recess comprising an index of refraction and a dimension sufficient to cancel background light energy incident on the detector surface in a detection band of the sensor array" in combination with the other limitations of the claim.
