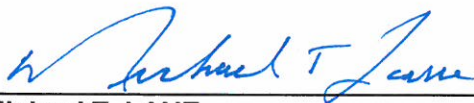

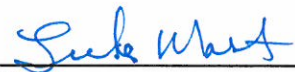

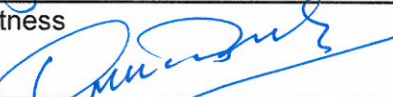
applications as aforesaid, to issue the Letters Patent, Utility Model Registration or other similar right to Assignee.

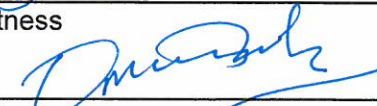

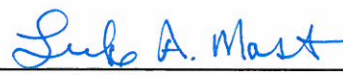
