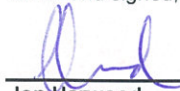
NC2024/0015211 for – “MEDICAL GASES CONDUIT”

, for which purpose we authorize them to take before the said authorities all the necessary steps for the said end; to file petitions, declarations, claims, recourses and withdrawals; file and prosecute PCT international applications, to draw up specifications; to file amendments, to limit the scope of applications, file oppositions; file cancellations total or partially waive registrations, to pay all installments and effect all other payments prescribed by law; to receive proper receipts, to comply with all other requirements and, in short, to take all those measures which they may deem fit for the protection of our interests; and in case of opposition, where the proceedings be passed over to the courts, we authorize said agents to act on our behalf, as complainants as well as defendants, before the competent judges, with full powers to make arrangements, to submit to arbitrators, to conciliate, to desist, to collect, to appeal and, in short, with all such further powers as may be required, and we hereby declare from now on as valid and good all that said representatives and/or the agents by any one of them appointed may do for our benefit. However, it is expressly noted that the attorneys may not delegate their powers without the prior and explicit consent of **FISHER & PAYKEL HEALTHCARE LIMITED**.

Likewise, they are empowered before the office of the general attorney delegated to administrative conciliation to represent the interests of **FISHER & PAYKEL HEALTHCARE LIMITED** and to request, represent and carry out all the necessary actions in the extrajudicial conciliation process as a procedural requirement within the referenced process, as well as to attend the conciliation hearing that is scheduled.

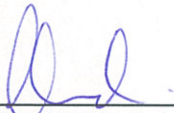
