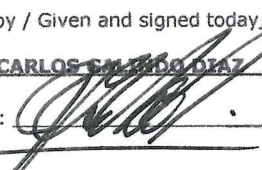

N° 107.240 of the Superior Council of the Judiciary..., to obtain the protection of our Industrial Property, to which effect we authorize him to represent us before any of the administrative, official and jurisdictional persons or entities, in order to : 1) obtain from the offices and appear before any of them and all courts, in order to enforce a right or respond to all claims or demands that may be filed due to applications or registration of industrial property; 2) intervene and act in all kinds of judicial or administrative proceedings in order to protect the rights of the company with respect to its industrial property; 3) to give confessions and affidavits; to acknowledge signatures; to refer matters to the decision of appointed or proposed arbitrators; 4) to denounce crimes and file criminal actions against third parties that infringe on the acquired rights of the company; 5) enter into administrative and judicial transactions and settlements in connection with claims or complaints; waive obligations and grant reductions in amounts and extensions of time; represent the company as a victim or injured party; 6) file incidents of indemnification/compensation/resolution of claims and appeals, recusals and waiver of the same; 6) to promote incidents of compensation/complete reparation; to accept the application of the principle of opportunity, to file any kind of lawsuits including those of reparation, contentious-administrative, reinstatement, revocation, appeal and cassation and in general all other administrative or judicial measures, acting in self-defense of the interests, assets and actions of the company. 7) Register before the DIAN and customs the trademarks in the directory of trademark holders, in order to protect the intellectual property rights of the principal with respect to the merchandise that enters and leaves the country.
