Apply for protection of its copyrights, follow the respective proceedings, obtain, and register them, as well as protect its industrial secrets and know-how; 3. The Attorneys are empowered to carry out all the acts required to finalize the tasks entrusted to them, as well as to receive, desist, substitute and reassume this power of attorney, settle, resign, and in general, for any other act in defense of the rights of the grantor. ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Davinci Tech - Team Foods (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

Consequences of changing your mind
