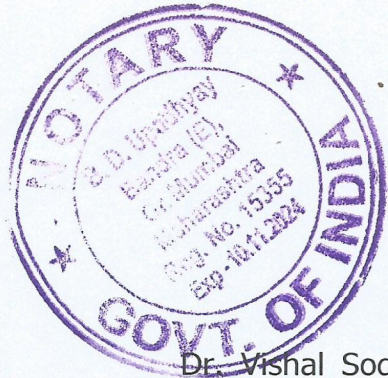
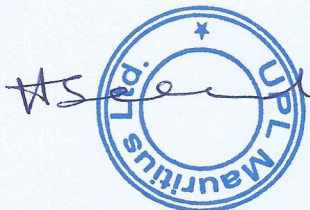




General Power of Attorney

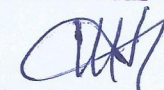
